# H2020MSCA – Individual Fellowships- Main Objective

## Main Objective

To enhance the **creative** and **innovative potential** of experienced researchers wishing to diversify their individual competence in terms of **skill acquisition** through **advanced training, international** and **intersectoral mobility**.

# MSCA – Individual Fellowships -ST

## MSCA -ST are opened to:

- ✓ **Experienced researchers** *i.e.* be in possession, at the date of the call deadline, of a doctoral degree or have at least 4 years of full-time equivalent research experience.
- ✓ Researchers may be of **any nationality** and **no age restrictions**
- ✓ Researchers must comply with the **mobility** rules *i.e.* must not have resided or carried out his/her main activity (work, studies, etc.) in the host country for more than 12 months in the 3 years immediately before the call deadline.
- ✓ One Experienced Researcher applies jointly with **one host institution located in a Member State or Associated Country** for a research project than can last between **12 and 24 months**.

# MSCA – Individual Fellowships **Global Fellowships (GF)**

## MSCA GF are opened to:

- ✓ **Experienced researchers** *i.e.* be in possession, at the date of the call deadline, of a doctoral degree or have at least 4 years of full-time equivalent research experience.
- ✓ Researchers may be **a national** or **long-term resident** of a **MS or AC**  
*Long-term resident = who has carried out a full-time research activity in a EU MS or AC during at least 5 consecutive years.*
- ✓ Researchers must comply with the **mobility** rules *i.e.* must not have resided or carried out his/her main activity (work, studies, etc.) in the **Third Country Partner organisation** where the initial outgoing phase takes place for more than 12 months in the 3 years immediately before the call deadline.
- ✓ One Experienced Researcher applies jointly with **one host institution located in a Member State or Associated Country** for a research project that can last between **24 and 36 months**.
- ✓ This application is done **in collaboration** with a **Partner organisation** located in a **Third country (TC)** where the mandatory outgoing phase will be performed.

➤ *Based on an outgoing phase to a third country (12-24 months) and a mandatory return phase (12 months) to a MS or AC*

# MSCA – Individual Fellowships **ST & GF**

## Financial aspects:

<b>Individual Fellowships</b>	4,880	600	500	800	650

Living allowance: It is a **gross EU contribution** to the salary cost of the researcher. Benefits and taxes have to be deducted to get the net salary. This amount is adjusted through the application of a country correction coefficient according to the living costs of the country.

Mobility allowance: It is an **additional fixed EU contribution** paid to the researcher.

Family allowance: It is an **additional fixed EU contribution** paid to the researcher in case of family obligations, defined as marriage, formalised relationship, dependent children. The family status is determined at the deadline of the call and will not be revised during the lifetime of the action.

Mobility and family allowances may be taxable depending on the country where the action is carried out!

# MSCA – RISE « Research and Innovation Staff Exchange »

The objective of the RISE scheme is to promote **international and intersectoral collaboration** between participating organisations (*i.e. consortia of Beneficiaries and TC Partner organisations*) **through R&I staff exchanges**, and sharing of knowledge and ideas from research to market (and vice-versa).

**Staff:** Researchers, technical, administrative and managerial staff of any nationality and at all career levels

## ***Minimal conditions for RISE consortium***

The minimal conditions to pay attention to when forming a RISE consortium consist of three elements:

**Organisations:** Composed of at least three organisations independent of each other

**Countries:** Organisations established in three different countries, of which at least two must be different MS and/or AC

**Sectors:** For consortia composed of MS/AC countries only, at least one organisation should belong to a different sector (academic or non-academic)

Above these minimum requirements, additional organisations established in MS/AC

# MSCA – RISE « Research and Innovation Staff Exchange »

Staff member unit costs	Institution	
	Research, training and networking costs	Management and indirect costs
2,100	1.800	700

## **Staff member unit cost:**

Is a top-up allowance to be fully used to support travel, accommodation and subsistence costs for the staff member during the secondment

On request, the Beneficiaries must be able to show that the total amount (2,100 EUR) was fully used for the direct benefit of the seconded staff member.

**Important!** The salary of the seconded staff members or any other type of remuneration is not covered by the EU contribution. Therefore, the Beneficiaries and TC Partner organisations are expected to continue paying the staff member's salary (or any other type of remuneration) during their stay abroad.

## **Research, training and networking costs**

costs of R&I related activities of the action such as purchasing of consumables, laboratory costs, participation to conferences, workshops, coordination and review meetings and networking activities.
